



**CALL FOR APPLICATIONS – CYCLE 2027-2028  
PROGRAM FOR BRAZILIAN CITIZENS  
FOREIGN LANGUAGE TEACHING ASSISTANT (FLTA) PROGRAM**

The **FLTA** is a non-degree program fostering Portuguese language proficiency at U.S. colleges and universities. It provides an opportunity for young recent graduates from Brazil to refine their teaching skills, increase their English language proficiency, and extend their knowledge of the cultures and customs of the U.S. Grantees will engage in non-degree studies while strengthening Portuguese language instruction and Brazil's cultures and traditions at U.S. colleges and universities. The Commission will award up to **twelve grants** to young recent graduates to teach Portuguese and Brazilian culture to American students at universities and colleges for one academic year (nine months), beginning in August/September 2027 and ending in May/June 2028. FLTAs must attend two academic courses per semester, one of which will be related to American studies (American history and culture).

***The 2027–2028 awardees will stand out as Fulbright Brazil's 70<sup>th</sup> cohort, a milestone in the bilateral academic exchange.***

### **1. ELIGIBILITY**

The candidate must have an **undergraduate degree in Portuguese and/or English** from a 100% four-year-long in-person program, be 30 years old or younger before departing for the U.S. in August 2027, and fulfill the English language requirements specified below. Applicants cannot cumulate this award with any other similar grant for the same purpose. Dependents cannot accompany candidates during their assistantships and must be able to travel to the U.S. without an escort. The candidates must be Brazilian citizens, and dual Brazilian/U.S. citizens are not eligible. The candidate must remain in Brazil for the entire selection and affiliation process, and until departure to the United States. FLTA minimum English language requirement is assessed through standardized test scores, obtained after **July 2025**: 81 (Internet Based TOEFL - iBT); 6.5 (IELTS); or 110 (Duolingo).

### **2. FUNDING**

The program funds:

- Monthly maintenance: to cover living expenses, variable accordingly to the host institution;
- International air ticket;
- Book allowance;
- Settling-In allowance;
- Limited health care benefit plan (ASPE - Accident and Sickness Program for Exchanges);
- Orientation Seminar; and
- J-1 visa fee.

### **3. SUBMISSION GUIDELINES**

The candidate must carefully read the Application Instructions and submit the online application form, both available at [www.fulbright.org.br](http://www.fulbright.org.br), including all the following **mandatory supporting documents**:

- **Brazilian passport ID pages**, if available, or official ID document with photo (CNI, RG or CNH).
- **Academic transcripts**: Applicants must submit official, complete, and certified diplomas and transcripts **in Portuguese**, covering the entire period of study at universities and other post-secondary institutions;
- **CV in English**, no more than two pages;
- TOEFL, IELTS, or Duolingo **score report**;
- **Copy of previous DS-2019 forms and visas** on the passport (original document) if the candidate has already received a J-1 visa; and
- **Three letters of reference in English**.

Applicants must also send through the Fulbright Brazil Platform, available at the Commission's website, **a thirty-seconds video clip** in English as part of the selection process, answering the question: **why do you want to be an FLTA?**

Candidates must submit both their application and the video by **August 2nd, 2026**. The Fulbright Commission will not consider applications with inaccurate, insufficient, or inconsistent data or missing supporting documents and video.

#### **4. SELECTION PROCESS**

The Fulbright Commission will screen and select all valid applications. A peer-review panel nominated by the Commission will assess candidates' academic and professional qualifications. All selected candidates will be interviewed by videoconference in English.

The Fulbright Commission will nominate the pre-selected candidate for approval by the J. William Fulbright Foreign Scholarship Board (FFSB).

The candidates will then participate in the placement process, which will be selected by a host university. Only then will the candidates be confirmed in the Program.

NOTE: Plagiarism will result in disqualification from participating in the program.

#### **5. TIMELINE**

- **August 2, 2026:** deadline for online application and video clip submission;
- **October/November 2026:** videoconference interviews;
- **December, 2026:** results of the selection process;
- **August/September 2027:** start of activities in the U.S.

#### **6. ADDITIONAL INFORMATION**

Grantees will be required to complete their Fulbright grant in the academic program specified in the grant document. Grant dates and funding amounts stated in the grant document are subject to change. Prospective Fulbright participants should be aware that public health conditions, availability of consular services and travel, as well as U.S. institutional operating status and policies may affect their ability to travel to the U.S. and participate in academic programs. The grant is activated only if the grantee can obtain a passport, J-1 visa and enter the United States to start the academic program outlined in the grant document.
